

“MTN Recharge Competition

Blu Label Distribution, ENGEN and MTN

Terms and Conditions

1. The Engen and Blue Label “**MTN Recharge**” Competition (the “Competition”) will be conducted exclusively between selected South African Engen franchisee site customers (“**ENGEN**”) of Blue Label Distribution Proprietary Limited (2004/003066/07) (“**Blue Label**”), that sell MTN prepaid airtime vouchers.
2. Blue Label Distribution and Mobile Telephone Networks Proprietary Limited (1993/001436/07) (“**MTN**”) are hereinafter collectively referred to as “**The Organizers**”
3. The Competition period is from the **01st November 2024 to 31st December 2024** (both days inclusive) (the “**Competition Period**”) and the competition will take place in South Africa.
4. The Competition is open to the general public (“**Consumers**”) who are physically present at and who purchase MTN prepaid airtime vouchers at **ENGEN** outlets. Save as aforesaid the directors, members, partners, employees or agents of, or consultants of the Organizers (and their affiliates and immediate family members, life partners, business partners or associates) are excluded from the Competition, as are the Organizer’s advertising agencies and suppliers. In addition, to be eligible to participate in the Competition, qualifying participants who are natural persons must be at least 18 (eighteen) years of age.
5. By participating in the Competition, Consumers agree to be bound by these Terms and Conditions, which will be interpreted by the Organizers in their sole discretion. All decisions taken by the Organizers in relation to the Competition, or in respect of any dispute, shall be final and binding.
6. **How to participate Consumers:**
 - a. Consumers are to participate by purchasing a R30 or more MTN airtime or data bundle pre-paid voucher and enter the Competition by SMSing ‘**MTN**’, name, Serial number and **ENGEN** retail store name where the voucher was purchased to the shortcode 30811.
 - b. During each calendar week of the Competition Period (which may be rounded up or down by a day or two by the Organizers) for 8 (eight) weeks of the Competition Period a Consumer will stand a chance to win :
 - i. 1 of 10 Cash Prizes of R1,500 each.
 - ii. 1 of 10 Samsung Galaxy A25 smartphones.
 - iii. 1 of 2 Laptops valued at R10,000 each.
 - c. The Organizers shall pick a winner each week in a fair and unbiased manner, such that every Consumer has an equal chance to win.

The Organizers also have the right to withdraw or modify this promotional offer (“**Promotion**”) and participants will not have any claim against the Organizers of any nature in relation to the Competition. The participants choosing to participate indemnify the Organizers, their directors, affiliates, members,

partners, employees, agents, consultants, suppliers, contractors and sponsors against any loss or damages, either direct, indirect, consequential, or otherwise, arising from its participation in this Competition.

8. The Organizers will not accept any liability or responsibility for any damage, loss, injury or disappointment suffered by participants. The Organizers will not be liable for any costs incurred by participants in relation to the Competition.

The Organizers may amend, modify or otherwise change these terms and conditions in their sole and absolute discretion on notice to participants and the amended version will be displayed in the same media as these terms and conditions. By participating or continuing to participate in the promotion participants agree and understand that they will be bound by the amended terms and conditions.
10. The Organizers is not liable for any technical failures affecting participation and/or promotion reward redemption process of the Competition.
11. The Organizers assumes no liability whatsoever for any entry that has been omitted from participation in the Competition for any reason whatsoever.
12. The Organizers has no control over the interception or loss of personal information over the internet and assumes no liability for any such interception or loss.

Notwithstanding anything to the contrary contained herein, to the maximum extent permissible by law, Consumers, waive any claim they may have against the Organizers for any reason whatsoever and indemnify the Organizers accordingly. Without limitation, the Organizers shall not attract any liability for any damage or loss you suffer as a result of injury or loss the aforesaid participants suffer by participating in this Promotion.
14. By participating in the Promotion, consumers waive any and all rights to bring any claim or action related to such matters in any forum beyond one (1) month after the first occurrence of the kind of act, event, condition or omission upon which the claim or action is based.
