

‘Orange is the new Blu Reloaded’ Competition Terms and Conditions

Orange is the New Blu competition Reloaded terms and conditions

1. The Orange is the New Blu Reloaded competition (the competition) runs from 00:01 on 01 January 2025 until 23:59 on 31 March 2025.
2. The Orange is the New Blu Reloaded competition is run by Blue Label Distribution (Pty) Ltd and World Sports Betting (Pty) Ltd.
3. By participating in the competition, you agree to the following terms and conditions.
4. How to Enter:
 - 4.1 You must purchase a Blu Voucher for a minimum of R100 (one hundred rand) and deposit the voucher into your World Sports Betting online account during the competition period.
 - 4.2 You must place at least one real money bet during the competition period.
5. Entry is open to all South African residents over the age of 18 (eighteen) years.
6. Entry is open to individual entrants in South Africa only – group and company entries are not permitted.
7. Each person is allowed unlimited entries into the competition, provided all the entry criteria as set out in the terms and conditions have been met.
8. A valid FICA-approved World Sports Betting account is required to enter.

 - 9.1 There are 12 (Twelve) prizes of R25 000.00 (twenty-five thousand rands) each, making a total amount of R300 000.00 (three hundred thousand rands), which will be paid as cash into the winner's World Sports Betting account.
