

“MTN WIN WIN Data Deals” Competition

Terms and Conditions

1. The MTN and Blue Label ‘Win Win’ Competition (the “Competition”) will be conducted exclusively between MTN and Blue Label (referred to as the “Organizers” or “MTN and Blue Label”), in South Africa from the **1st day of July 2018** until the **31st day of January 2019** (both days inclusive) (the “Competition Period”).
2. The Competition is open to all South African residents (excluding the directors, members, partners, employees or agents of, or consultants to the Organizers including their affiliate companies or their immediate families, life partners, business partners or associates, the Organizers’ advertising agencies and suppliers) who have purchased MTN Data Vouchers at any participating Sasol, Engen, Jwayelani, Spar, Edgars Connect or Global Petroleum store in South Africa during the Competition Period.
3. In addition, to be eligible to participate in the competition, qualifying participants must be at least 18 (eighteen) years of age, with a valid South African ID and a valid South African driver’s licence.
4. By entering the Competition, you agree to be bound by these Terms and Conditions, which will be interpreted by the Organisers at its sole discretion. All decisions taken by the Organisers in the course of the Competition, or in respect of any dispute, shall be final and binding. Any breach of these Terms and Conditions may, at the Organizers’ absolute discretion, result in forfeiture of any prize.

How to enter:

5. Purchase an **MTN Data Voucher** from any participating Sasol, Engen, Jwayelani, Spar, Edgars Connect or Global Petroleum store (RSA only) and load the said MTN Data Voucher onto your RICA compliant MTN SIM card.
6. SMS the keyword to **30811**. SMS’s are charged at R0.00 and free minutes or bundled SMS’s do not apply. VAS rates may apply.
7. A single MTN Data Voucher will entitle you to a single Competition entry. You may, however, enter the competition more than once by purchasing further MTN Data Vouchers.
8. One winner will be drawn each month for a period of 7(seven) months, namely for the periods 1 July 2018 to 31 July 2018; 1 August 2018 to 31 August 2018; and 1 September 2018 to 30 September 2018; and 1 October 2018 to 31 October 2018; and 1 November 2018 to 30 November 2018; and 1 December 2018 to 31 December 2018; And 1 January 2019 to 31 January 2019.

Prizes to be won:

9. By purchasing a **MTN Data Voucher** from any participating:
 - 9.1 **Sasol, Engen, Jwayelani, Spar, Edgars Connect** or **Global Petroleum** and subsequently entering the Competition you may stand a chance to win:

- 9.1.1 One of 7 (seven) VW POLO Vivo motor vehicles.
- 9.2 **Sasol, Engen, Spar or Edgars Connect** and subsequently entering the Competition you may stand a chance to win either:
- 9.2.1 Your share of R500 000.00 (Five Hundred Thousand Rand) or the prize listed in 9.1.1 above.
- 9.3 **Jwayelani** and subsequently entering the Competition you may stand a chance to win either:
- 9.3.1 One of 3 (three) Swift 150 Big Boy Scooters and/or your share of one of 20 (twenty) trolley dashes in such Jwayelani store or the prize listed in 9.1.1 above.
- 9.4 **Global Petroleum** and subsequently entering the Competition you may stand a chance to Win either:

9A. PLEASE TAKE NOTE THAT prizes listed in this clause 9 are listed separate and not in addition to each other and as a result and for the avoidance of doubt you will not be able to win more than one of the prizes listed in this clause 9 above, regardless of the participating store at which you have purchased your MTN Data Voucher used to enter the Competition.

10. If you are a winner:
- 10.1. You will be contacted by the Organisers. All winners will be contacted either via social media, direct messaging, email or telephonically;
- 10.2. Winner selection will take place at the end of each of the seven monthly periods mentioned in clause 8 above through the duration of the Competition;
- 10.3. **You are required to retain your till slip / MTN Data Voucher, to verify and validate your entry, should you be drawn as a winner;**
- 10.4. You will be required to produce a valid South African ID as well as a valid South African driver's license (if applicable) as proof that you are the legal winner of the competition prize;
- 10.5. The Organizers shall attempt to contact the respective winners for a period of 2 (two) working days after their name has been drawn and verified as a winner;
- 10.6. Should a participant not be available during the timeframe stipulated in 10.5 above or rejects, forfeits or declines acceptance of the prize, that person's right to the prize will be deemed to have been waived and the prize will be forfeited. The Organizers reserves the right to then award the prize to the next random drawn person;
- 10.7. If you cannot provide proof, or meet all the competition conditions to The Organizers' satisfaction, you agree that you will not be entitled to the prize and the prize will once again

be placed into a separate draw. You will have no claim against the Organizers if this happens;

- 10.9. The colour of the Prize (if applicable) will be solely determined by the Organizers subject to availability;
- 10.10. The judges' decision is final. The Organizers confirm that they will ensure that a chartered accountant, registered auditor, admitted attorney or commissioner of oaths conducts the competition and this will be reported on the Organizers' internal audit reporting procedures; and,
- 10.11. the Organizers will ask your permission to utilise your name, photograph and / or campaign related video content of you at no cost to you, for any advertising, promotional, print, point of sale or public relations material for a period of 12 (twelve) months from the end of the competition period.
11. The closing date of the Competition is 31 January 2019 and no late entries will be accepted after that date. The Organizers accepts no responsibility for entries lost, misdirected, illegible, late or altered.
12. The Organizers will conduct a randomised draw at the end of each of the seven monthly periods mentioned in clause 8 above. The winner/s of the Competition will be drawn from all the entries received during the various periods of the Competition.
13. You understand that all information (including these rules) relating to the Competition published on any promotional or advertising material or on our website at any time before or during the competition period will form part of the terms and conditions of entry.
14. The Organizers also has the right to withdraw or modify the Competition before the End Date of the Competition Period (31 January 2019). You will not have any claim against The Organizers in this event.
15. It is important that you understand that you and all participants indemnify the Organizers, its directors, affiliates, members, partners, employees, agents, consultants, suppliers, contractors and sponsors against any loss or damages, either direct, indirect, consequential or otherwise, arising from its participation in this competition.
16. The Organizers will not accept any liability or responsibility for any damage, loss, injury or disappointment suffered by any you as a result of entering the Competition or accepting any Prize, as the case maybe.
17. The Organizers will not be liable for any costs incurred by you in claiming a prize.
18. The Organizers may amend, modify or otherwise change these terms and conditions in its sole and absolute discretion on notice to you and the amended version will be displayed in the same media as these terms and conditions. By participating or continuing to participate in the competition you agree and understand that you will be bound by the amended terms and conditions.

24. Organizers' entire liability and your sole and exclusive remedy will be limited to a distribution of the equivalent amount of Prize as set forth above. 25. Any personal information relating to you that is collected by the Organizer during the Competition will not be shared with any third party without the participant's express written consent. By entering this Competition, you agree that the Organizers may make media announcements and/or publications of the winner(s). The Organizers may also communicate with you from time to time at the Organizers' discretion from which you can opt out at any time.
26. South African law applies to the operation of the Competition and the Johannesburg Magistrates court shall have jurisdiction over any and all disputes or claims which may arise from your participation in this Competition.
